| <p>Considering the advance of neo-fascism in Europe with the increasing normalisation and impunity of fascism, racism, xenophobia and other forms of intolerance, especially worried about the neo-fascist violence attacking democracy and targeting minorities, third-country nationals, LGBTI people and persons with disabilities; considering the BNG was attacked by the Franco Foundation;</p> <p>the European Free Alliance:</p> <ul style="list-style-type: none"> <li>- Condemns and deplors the terrorist attacks, murders, psychological violence, violent physical attacks and marches by neo-fascist and neo-Nazi organisations that have taken place in various EU Member States;</li> <li>- Calls on the Member States to follow the Resolution of the European Parliament on the rise of neo-fascism in Europe and urges the Commission to update its 2014 report on the implementation of the Council Framework Decision 2008/913/JHA on combating certain forms and expressions of racism and xenophobia by means of criminal law, and to initiate infringement proceedings against those Member States that have not complied with the provisions of the Decision;</li> <li>- EFA urges the Member States to counter organisations spreading hate speech and violence in public spaces and online and to effectively ban neo-fascist and neo-Nazi groups and any other foundation or association that exalts and glorifies fascism.</li> </ul> |                                        |
